The Editor is responsible for editing and preparing four issues of the *CDQ* per year, preparing an annual report for the NCDA Board, and coordinating business functions of the *CDQ* with ACA officials including plans for expansion of subscriptions. The *CDQ* Editorial Board Members are recommended by the Editor and approved by the NCDA Board. The Editorial Board is responsible for editorial policy and content of the *CDQ*.

# ACTIVITIES TO DATE:

- 1. March 2017 issue submitted to production August 22, 2016.
- 2. June 2017 issue submitted to production November 18, 2016.
- 3. September 2017 issue submitted February 10, 2017.
- 4. Responded to numerous inquiries about CDQ policy, NCDA resources, manuscripts, publication guidelines, journal ratings, acceptance rates, and the like.
- 5. Journal statistics for the 12-month period prior to March 8, 2017:
  - 102 manuscripts received
    - 51 manuscripts rejected without review (inappropriate)
    - average time to assign reviewer = 1.8 days
    - average reviewer turnaround time = 27.1 days
- 6. Impact Factor = 0.873 (2-year), 1.18 (5-year).
- 7. Full text downloads via Wiley Online Library, EBSCO, and other third-party databases (2015) = 164,449
- 8. CDQ ranks 57 of 79 applied psychology journals worldwide

- 1. Submit December 2017 issue by June 1, 2017.
- 2. Submit March 2018 issue by September 1, 2017.
- 3. Forward nominations of new and continuing editorial members for NCDA Board approval by June 1, 2017.
- 4. Process all submitted and resubmitted manuscripts in a timely, efficient, and effective manner.
- 5. Provide all submitting authors with thorough, thoughtful, useful, and encouraging reviews.
- 6. Work with authors to publish articles of the highest quality.
- 7. Editor completes first year of second 3-year term December 2017.
